Myers bestowed the honors of PGCGHP on Norman Thomas, Walter Simms, Ben Mays and Lewis H. Nelson by presenting them the jewel of the office and receiving Grand Honors.

Final remarks from MWGM Lewis Davis. Sam Davis announced that Grand King Larry Johnson lost his brother today.

Parrott gave us an update and informed us that the top hotel staff was there with his daughter.

2:45 PM the Conference was closed with prayer by Rev. McFarland.

Report of the Committee on the General Grand Conference Most Excellent Grand High Address

We your Committee on the General Grand Conference Most Excellent Grand High Address submit the following report:

GCGHP John White started his annual address buy giving honor to God. He next acknowledged the dignitaries that were present starting with Most Worshipful Grand Master Lewis H. Nelson (South Carolina), Corey Hawkins (Alabama) along with his staff of General Conference Officers to include DGGHP Leslie M. Dean, Grand King Dr. James V. Blake, Grand Scribe Damon P. Anderson, all PGCGHP's, MEGHP's, DGHP's, Grand Kings, Grand Scribes; and Companions.

He followed with prayer.

He continued his address by reflecting back on his election on last year and thanked the Companions for the honor and opportunity to serve the General Grand Conference as its head.

He went on to talk about what could have or should have been but expressed his belief that we must look forward and not backward as there was greater benefit in the positive than in the negative. He further stated that the positive is what will keep the Conference moving forward.

He thanked those Jurisdictions that continue to participate in the King's Contest and for the love and commitment they continue to show the children. He also thanked the General Conference for their assistance with the contribution of funds for our scholarship recipients.

He went on by singling out some of his staff members for their outstanding efforts in supporting this General Grand Conference. To PGCGHP James R. Gaither for providing the jurisdictions with rituals. To the Web-master, PGCGHP Anthony K. Wells for getting the Web-site up to date. To PGCGHP Dr. Johnny McCray for the time and effort spent in keeping our books in order and paying the bills in a timely manner. To PGCGHP James E. Alston for maintaining his schedule and insuring that all correspondence was sent out in a timely manner. Lastly to the Assistant Grand Recorder Norman Thomas for his efforts in maintaining an accurate record of proceedings that occurred during our meetings.

GGHP White in his report on necrology reflected on the Companions who had made the transition from this earthly life to their eternal rest. He recited words of comfort from the scripture that spoke of their reception into "that house not made by hands eternal in the heavens"

He summed up his observations on the "state of the nation" by indicating that both political parties are continuing to make things difficult for our president. He spoke of the president's continuing efforts to extend unemployment benefits, raise the minimum wage and to improve the National Healthcare Program as just a few issues that he attempted prompt action on. He told of how some of these actions were forcing some of us to decide between the Masonic Order and our families realizing all that time that our families come first. He encouraged us to hold our heads high and do what we could to make the needed changes.

In his summary of the state of the General Grand Conference, he spoke of how we are continuing to move forward with the officers that you have elected and with the support provided by our member jurisdictions. He stated that

we must look forward to keep this Conference at its best. He further stated that we must be ever ready to face whatever awaits us.

He addressed the fact that during PCGGHP Roosevelt Huggin's administration, the Conference voted to acquire a Headquarters in Fort Worth, Texas to house our Conference property at a cost of \$100.00 per month or \$1200.00 per year. This was agreed to verbally. He said that he would like to see our legal advisor, Attorney Harrison Gregg Jr, pursue entering into a written agreement to protect our interest.

He went on to thank the Alliance Presidents for hanging in there when he knew that there were times when they wanted to throw up their hands and walk away. He also thanked the Alliance Deputies for the job they did during the year and how their commitment to work with the deputies was greatly appreciated. He stated his intention to appoint deputies in the areas with vacant slots.

His final thanks went to PGCGHP Willie Tate for the job that he has done and continues to do as our Conference Coordinator and how he had traveled back and forth between Colombia and Nashville to conduct the business of this Grand Conference. He further that Companion was always available to address any problems that we may encounter.

He moved on to a list of 6 (six) recommendations that he wanted the Conference to address. We reviewed these recommends and suggest that they be referred to the proper committee for action.

In his closing thought, he said "there is good, better and best, may we each strive to make our good better and our better best".
