Greetings:

By the authority in me vested and agreeable to the Constitution and By-Laws governing the Most Excellent Prince Hall Grand Chapter of Holy Royal Arch Masons of the state of Michigan, be it known that I, Mark E. Lynn, Most Excellent Grand High Priest, do hereby proclaim that on Saturday, April 20, A.D. 2024, A.I. 2554, the 144th Annual Grand Convocation of Holy Royal Arch Masons will be convened in the city of Kalamazoo, Michigan, at the Radisson Plaza Hotel, 100 W. Michigan Avenue, Kalamazoo, Michigan 49007.

I hereby summon all Grand Chapter Officers, Past Grand High Priests, Past and Present, Excellent High Priests, Kings, Scribes, and all Royal Arch Masons to be present.

A Chapter of Royal Arch Masons will open their Chapter at 8:00 a.m. and will be prepared to receive the Right Excellent Deputy Grand High Priest and the cabinet at 8:30 a.m. Once the Grand Convocation is declared open, we will go from labor to rest until 1pm. We will join the Heroines of Jericho for their Convocation and have Lunch with them at 12pm. We will return to labor at 1pm and be done with our business at 5pm.

REGISTRATION: Advance registration is \$100 which will include lunch. After April 10, 2024, the registration fee will be \$150 which will not include lunch.

Per the Constitution and By-Laws of the Most Excellent Prince Hall Grand Chapter, the three principle officers (Excellent High Priest, King and Scribe) of each Subordinate Chapter and all Appointed Grand Chapter Officers are required to register and attend the Grand Convocation. **Each Chapter is responsible for the \$300 registration fee of their principle officers; whether they are in attendance or not.** Subordinate Chapters and Companions are requested to pre-register before the cutoff date of April 10, 2024.
